## **COMMITTEE REPORTS**

They are anticipating a \$60,000 savings on their electric. There will be a minor decrease in the 2019-2020 Delsea Regional School Budget. Aura School Budget will be a 42 cent decrease per \$100 of assessed value.

Mayor Sammons reported for Environmental. The Arbor Day celebration was a success. The girl scouts installed the new sign for Elephant Swamp Park. Many thanks to Jenna Master and Sydney McKeever for putting the project together and raising the funds for a new sign.

# POLICE CHIEF REPORT

Jennifer Johnson, 211 Buck Road, asked if there is an update to the drainage issue on Arch Street. Ms. Bey continues to pump water to the street, which is flooding her yard.

Mr. Duffield will review the township ordinance.

Mr. Schomber stated he took a ride and looked at the property that is pumping and states the property is higher than the road and water is going to drain to the street.
