# ELK TOWNSHIP COMMITTEE MEETING MINUTES July 16, 2019

The Regular Meeting of the Elk Township Committee was held on the above date in the Municipal Building. The meeting was called to order by Mayor Sammons at 7:05PM.

### APPROVAL OF MINUTES of June 18, 2019 Work Session

Motion by Mr. Poisker, seconded by Mrs. Nicholson to approve the minutes of the June 18, 2019 Work Session, motion carried with Mr. Hollywood abstaining.

### **COMMITTEE REPORTS**

Mrs. Nicholson reported the Environmental Commission will meet again in September. They are working with Circuit Trails to obtain a grant for Elephant Swamp trails to become a part of Circuit Trail.

### POLICE CHIEF REPORT

Chief Hughes reported for the month of June, the department received 958 call for service, responded to 13 motor vehicle crashes with 2 injuries, issued 340 motor vehicle summons and made 14 arrests. Nine officers attended several different training seminars.

### FIRE DEPARTMENT REPORTS

Mr. Rambo read the reports that were submitted for the month of June.

Aura Fire Company responded to 15 calls for service. Training continues on the new truck.

Lawn's Fire Company responded to 1 call.

There was no report submitted from Ferrell Fire Company.

### **ENGINEER'S REPORT**

Mr. Bitgood updated committee on his report. Fifth Avenue has been completed and closed out. Thornwood Drive project has also been completed and closed. Valle del Sol work is now complete. The street trees and basin are the responsibility of the HOA. The project has been approved for release.

South Jersey Gas is installing gas mains in the Lawn's area and Mr. Bitgood has issued a stop work order to the contractor for unsafe conditions being left. He will be meeting with them to get them back on track. SJ Gas is in agreement with the stop work and regrouping to get the contractor back on track.

Mrs. Nicholson asked if the plug on Ewan Road can be removed. Mr. Bitgood stated the DEP has been in contact with Mr. Shomber concerning the plug. Mr. Bitgood stated the plug should be removed as soon as possible. The crack in the road is progressing and is across the entire road. There is no evidence of a sink hole but most times you are not aware of a sink hole until it is completely undermined.

The problem with the basin at Valle del Sol is being exasperated due to the plug in the pipe. There is a mosquito problem also. Mr. Bitgood has surveyed the area. The DEP verbally explained to Mr. Shomber that they are not directing or authorizing the plug to remain in the township right of way.

Mr. Duffield will be contacted to see how to go about acting on the removal of the plug.

### **TOPIC:**

Mr. Mark Reeves would like to purchase Block 30 Lot 19 located at 702 Jacob Harris Lane. The Township Committee approved the sale of this parcel by ordinance on June 2, 2016. The sale was never conducted. The property is a landlocked parcel that is 92' x 76' x 67', that was valued by the Gloucester County Tax Assessor at \$300 in 2016. The property can be offered for sale to all adjacent property owners at a private land sale. Mayor Sammons suggested making the purchaser to incorporate this property part of their adjacent property.

The public works department would like to replace 5 trash receptacles in the park. There are 5 cans that are approximately 30 gallons with flat lids and hold water. They would like to replace them with 55 gallon drums with domed lids. Committee approved the change.

**GLOUCESTER COUNTY REPRESENTATIVE**, Leona Mather was present to assist with any questions for the County. Mrs. Nicholson would like an update on the progress of the bike trail.
