#### **COMMITTEE REPORTS**

Mrs. Nicholson stated the Environmental Commission did not meet in August, the next meeting will be on Wednesday, September 11, 2019 at 7PM.

Mayor Sammons thanked the County for coming out to show the movie in the park. It was a great night.

#### POLICE CHIEF REPORT

Lt. Gonnelli reported the Police Department in the month of August received 840 calls for service, 12 crashes with 1 injury, issued 329 motor vehicle summons and made 18 arrests.

#### FIRE DEPARTMENT REPORT

Mr. Rambo read the fire department reports. For August, Ferrell Fire Company responded to 10 calls for service. Aura Fire Company responded to 8 calls for service. There was no report from Lawn's.

#### **ENGINEER'S REPORT**

Mr. Bitgood summarized his report. Gas work inspections in the Lawn's area have been completed. He is still waiting on the bond company for Aura to settle or complete a landscape plan. They have requested another copy of the plan. Bids have been received for the Stanger Avenue project. Committee will consider awarding this later on the agenda.

Mr. Bitgood made a presentation to Committee and residents on the Gloucester County Proposed Wastewater Management Plan. The county is responsible for sewer service area and GCUA approves the allocation. Mr. Bitgood has been working with the county on this map since 2016. Mr. Bitgood showed the progression of the maps from 2016 to 2019. There are still several areas of Elk Township that need to be included in the plan. Committee will be considering a resolution later in the meeting to ask the county to consider adding several blocks and lots.
