Mr. Clark will research other ordinances and report back to Committee for their consideration.

Ed Pearson, 1457 Ellis Mill Road, asked to have the information on the bus so the seniors can look into the purchase further.

Carl Williams, 242 Stanger Avenue, asked what the purpose of installing storm drains on Stanger Avenue is. There has not been a problem and he feels this is going to create a problem.

Mr. Bitgood stated the installation of the storm drains will help with the maintenance of the roads by not having standing water on the sides of the roads. Stormwater management is a major factor in any reconstruction of roadways, in order to be eligible to receive grant funds.
