# ELK TOWNSHIP COMMITTEE MEETING MINUTES March 5, 2020

The Regular Meeting of the Elk Township Committee was held on the above date in the Municipal Building. The meeting was called to order by Mayor Sammons at 7:03PM.

The Open Public Meeting Notice was read. The Salute to the Flag and the Lord's Prayer were recited in unison.

Present were: Mrs. Nicholson, Mr. Poisker, Mayor Sammons, Mr. Considine, CFO, and Mrs. Pine, Township Clerk, Mr. Duffield, Solicitor, Mr. Bitgood and Chief Hughes. Mr. Hollywood and Mr. Rambo were absent.

#### **APPROVAL OF MINUTES** of February 18, 2020 Work Session

Motion by Mr. Poisker, seconded by Mrs. Nicholson to approve the minutes of the March 5, 2020, Work Session, all were in favor motion carried.

#### **COMMITTEE REPORTS**

Mrs. Nicholson stated the Environmental Commission will meet on Wednesday, March 11<sup>th</sup> at 7PM, everyone is welcome.

Mayor Sammons announced the Egg Hunt in Recreation Park will be held on Saturday, April 5<sup>th</sup> beginning at 10AM. The raindate is April 11<sup>th</sup>.

### **POLICE CHIEF REPORT**

Chief Hughes reported the Police Department for the month of February received 897 calls for service, responded to 7 motor vehicle crashes with 3 injuries, issued 307 motor vehicle summons and 7 warnings, and made 28 arrests. Several officers attended several different training sessions.

The department also acquired a 2008 Crown Vic, a tactical flashlight and a walk through metal detector through the military surplus program.

#### FIRE DEPARTMENT REPORT

Mr. Rambo was not present to give the Fire Department Reports.

#### **ENGINEER'S REPORT**

Mr. Bitgood reported Stanger Avenue is completed. There is a proposed change order to correct areas that were exasperated by the paving; they are 2 additional inlets with perforated pipe and redo 2 driveway aprons.

Motion by Mr. Poisker, seconded by Mrs. Nicholson, authorizing Mr. Bitgood to proceed with change order pending DOT approval, all were in favor motion carried.

Mr. Bitgood hopes to have the Ewan Road preliminary design plans soon.

The NJ DEP has issued new stormwater rules. It will require more complicated and detailed designs. There will be more basins in developments, it will impact road reconstruction and small developments.

Mr. Bitgood received a request to vacate a portion of Twenty-third Ave. between Carl Ave. and the stream. He does not have an objection, but if the vacation is approved, he recommends retaining an easement for access.

**TOPIC: 2020 MUNICIPAL BUDGET-** Mr. Considine presented Committee with a draft of the 2020 Municipal Budget. It is based on current and projected salaries for contractual employees. There is no anticipated municipal tax increase. The amount of surplus that is being used will be \$715,000 where in 2019, \$871,000 in surplus was used. The pension payment was slightly reduced from last year. There are also funds in the budget to repair culverts on Iredell Rd. and Ninth Ave. The budget statutorily should be introduced at the next committee meeting on March 17<sup>th</sup>.

Committee will review and get back to Mr. Considine with their thoughts.
