Mr. Bitgood presented a Resolution for the Local Recreation Improvement Grant for Committee to consider. Mr. Poisker asked if the improvements include the surfacing with gravel and improving the cross walk. Is the parking lot going to be enlarged and is stormwater management also part of this application. Mr. Bitgood stated there may already be enough parking, a handicap parking spot needs to be added, for ADA compliance and the 2 street crossing signs and markings. The existing paved area near the entrance can be marked for the handicap spot. Mr. Bitgood stated the DEP has defined course paving as course asphalt or course concrete. If the course paving is used there is an exemption from a lot of stormwater rules. If course paving is not used the stormwater rules will have to be addressed. Mrs. Nicholson asked why we would have to address the stormwater rules if we are using stone? Mr. Bitgood stated the 1 acre of disturbance is what is pushing us to address the stormwater rules. The area could be reduced from the 1 acre disturbance. Mr. Bitgood mentioned having a conference call with the DEP to clarify. Mrs. Nicholson and Mr. Bitgood will contact the DEP.

TOPICS:

The Reopening of Municipal Building was discussed. Committee is in favor of opening the building provided the CDC Guidelines and Executive Order are followed. Masks must be worn when in the building, notices to wash hands or use hand sanitizer will be posted, and social distancing must be observed. A periodic cleaning throughout the day should be done also. The reopening will be Tuesday, June 1st.

The Construction Official has requested a correction in the Ordinance for Construction/Property Maintenance. There is a discrepancy in the fee for a CO in different portions of our code book. Committee would like to know if the Township can require a septic certification, when the state and county do not. Mr. Duffield will be contacted on this issue.

The police Lieutenant at a previous meeting presented Committee with his proposed structure of the police department and establishing a hierarchy. The Ordinance for the Police Department will need to be amended for this proposed structure. Lt. Gonnelli would like to have the positions listed with no limit on the number allowed. Mr. Duffield strongly recommends putting a number limit on the upper positions. Mr. Hollywood stated the structure needs to have the right supervision. After discussion the listing being considered is: 1 Chief, 1 Lieutenant, 2 Sergeants, 1 Detective Sergeant, Corporals, Patrolmen.
