Any help would be appreciated.

POLICE CHIEF REPORT

Chief Gonnelli reported the department received 1648 calls for service, made 9 arrests, issued 99 motor vehicle summons and responded to 9 motor vehicle crashes. There were 14 new firearm applications in May.

Police Appreciation Day was held on May 20th. The students from Aura School spent the day visiting the various participants. It was a great success.
