Redevelopment Plan (Aura III) review for Master Plan consistency

Board Planner, Candace Kanaplue, gave a brief summary of the Redevelopment Plan that includes the following:

Regarding fire protection, Mr. Hughes inquired about the following: were fire hydrants being installed, at proper intervals/spacing/feet apart on the water main along Rt 667, the road to the water tower and to the sleeve under Rt 55; on the water main from the other side of Rt 55, along 619, then 610 to the Silvergate development roadways; and on the extension of the water main on 667 up to the intersection with Rt 619, capped with a valve, all as described in Exhibit A. Ms. Kanaplue could not answer these questions and added that the board would have the opportunity to address these concerns at the time of site plan review.

Mrs. White moved to recommend to Township Committee the adoption of the Redevelopment Plan dated April 2020 by Resolution 2020-08. Seconded by Mrs. Nicholson.

The study is needed to obtain data on current and desired uses, on existing infrastructure that could with improvements, support cycling, walking, jogging & running.
