# A RESOLUTION OF THE ELK TOWNSHIP COMBINED PLANNING/ZONING BOARD AUTHORIZING CONTRACT WITH THE FIRM OF BACH ASSOCIATES, PC FOR PROFESSIONAL PLANNING SERVICES

WHEREAS, the combined Planning/Zoning Board of the Township of Elk has need of the services of a Professional Planner for the year 2022, to render professional advice to the combined Planning/Zoning Board on Planning/Zoning issues and to review applications for development, and

WHEREAS, funds have been budgeted for this purpose and have been certified by the Local Finance Officer; and

WHEREAS, The Local Public Contracts law (NJSA 40A:11-1 et seq.,) requires that the resolution authorizing the award of contracts for "professional service" without competitive bids on the contract itself must be available for public inspection; and

WHEREAS, the combined Planning/Zoning Board has selected the firm of Bach Associates, PC as the most appropriate firm to fill this position; and

**NOW THEREFORE, BE IT RESOLVED** by the combined Planning/Zoning Board of the Township of Elk as follows:

- 1. The firm of **Bach Associates**, **PC** is hereby appointed as the Planner for the Elk Township Combined Planning/Zoning Board for the year commencing January 1, 2022 and terminating December 31, 2022.
- 2. This contract is awarded without competitive bidding as a Professional Service contract under the provisions of the Local Public Contracts law NJSA 40A:11-5(1)(a) because the firm of Bach Associates, PC has previously served as the Planning/Zoning Board Planner and has special knowledge of the conditions of the Township which knowledge is particularly valuable to the Planning/Zoning Board. As such its services are of a nature where it is not possible to obtain competitive bids;
- 3. A copy of this Resolution shall be published once in the official newspaper, The South Jersey Times, as required by law within ten (10) days of its passage.
- 4. The Chairman and Secretary of the combine Planning/Zoning Board are hereby authorized and directed to execute an agreement with the firm of **Bach Associates**, **PC**.

THIS AGREEMENT, made this 21<sup>st</sup> day of January, 2022 between the Township of Elk Combined Planning / Zoning Board, Gloucester County, New Jersey, hereinafter referred to as the BOARD and Bach Associates, PC, a qualified planning firm in the State of New Jersey, hereinafter referred to as the PLANNER.

WHEREAS, the BOARD has appointed the PLANNER to the position of Combined Planning / Zoning Board Planner at the Board's 2021 Reorganization; and

WHEREAS, the PLANNER has designated representatives with the necessary background and expertise to provide the required planning services to the BOARD.

#### NOW, THEREFORE, it is agreed that:

- A. The PLANNER shall provide planning services to the BOARD for a period of one (1) year from date of the 2022 Board reorganization or until the 2023 Board Reorganization or until a successor is appointed. These services shall include general planning services and such additional supplemental services as may be required by the BOARD.
- B. The PLANNER will be compensated project basis based on a scope of services approved by the BOARD or on an hourly charge as set forth in the 2022 fee schedule provided as Appendix A.
- C. The PLANNER shall report to the BOARD as to the status of all pending or proposed projects.

D. The BOARD and the PLANNER each agree to indemnify and hold the others harmless, and their respective officers, employees, agents, consultants and representatives from and against liability for all claims, losses, damages, and expenses, including reasonable attorney's fees, to the extent such claims, losses, damages, or expenses are caused by the indemnifying party's negligent acts, errors, or omissions. In the event claims, losses, damages, or expenses are caused by the joint or concurrent negligence of the BOARD and the PLANNER, they shall be borne by each party in proportion to its negligence.
